This End User License Agreement (“Agreement”) is a legal agreement between you (“User,” “you,” or “your”) and Cellzier Pty Ltd (“Cellzier,” “we,” “us,” or “our”) regarding the use of all Cellzier software, bots, tools, and services (collectively “the Software”), including but not limited to the Cellzier AI tools provided within the Cellzier program and Discord server.

By accessing, downloading, installing, or using the Software, you agree to be bound by the terms of this Agreement.

1. LICENSE GRANT

Cellzier grants you a non-transferable, non-exclusive, revocable, limited license to access and use the Software solely for personal, non-commercial use as part of the Cellzier Program.

2. RESTRICTIONS

You may not:

- Reverse engineer, decompile, disassemble, or otherwise attempt to derive source code from the Software.
- Reproduce, distribute, sell, lease, sublicense, or commercially exploit the Software.
- Modify, adapt, or create derivative works based on the Software.
- Allow others to use your account, license, or tools provided within the Program.

3. OWNERSHIP

The Software and all associated content are the sole and exclusive property of Cellzier Pty Ltd. You acknowledge that no ownership rights are transferred to you under this Agreement. The Software is protected under copyright and trademark law, including but not limited to source code, UI/UX, databases, and custom logic developed by Cellzier.

4. TERMINATION

This Agreement is effective until terminated. Your license will automatically terminate if you breach any term of this EULA. Upon termination, you must cease all use of the Software and destroy all copies.

5. NO WARRANTY

The Software is provided “as is” and without warranties of any kind, either express or implied. Cellzier does not warrant that the Software will be uninterrupted, error-free, or suitable for your intended use.

6. USER CONTENT

Users retain ownership of any content they input into the Software, but grant Cellzier a worldwide, royalty-free, non-exclusive license to use, host, store, reproduce, and display such content solely for the purpose of delivering services and improving system functionality.

7. PROHIBITED CONTENT

You agree not to use the Software to:

- Violate any law or regulation.
- Upload, transmit, or distribute viruses, malware, or other harmful software.
- Infringe on the intellectual property or privacy rights of others.
- Harass, abuse, or harm other users of the Program or community.

8. LICENSE TERM AND RENEWAL (IF APPLICABLE)

License access is granted for the duration of your Program enrollment. If Cellzier transitions to a subscription-based service, you will be notified and given the option to renew under the updated model.

9. UPDATES AND MODIFICATIONS

Cellzier reserves the right to modify, update, or discontinue any part of the Software at any time without prior notice. Continued use following such updates constitutes acceptance of the new version.

10. EXPORT RESTRICTIONS

You may not use or export the Software in violation of applicable Australian export laws or regulations. It is your responsibility to ensure compliance with your local import/export laws.

11. LIMITATION OF LIABILITY

To the fullest extent permitted by Australian law, Cellzier will not be liable for any direct, indirect, incidental, or consequential damages arising from the use or inability to use the Software.

12. GOVERNING LAW

This Agreement shall be governed by the laws of Queensland, Australia. Any disputes arising from this Agreement shall be resolved in the courts of Queensland.

13. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between you and Cellzier and supersedes any prior agreements related to the Software.
